- Chemical Consumption: Using eco-certified cleaning products and reducing the use of harmful substances to protect health and ecosystems.
- **Greenhouse Gas (GHG) Emissions:** Tracking and lowering emissions through sustainable mobility, efficient energy use, and supplier collaboration.
- **Use of Raw Materials and Supplies:** Prioritizing environmentally friendly materials, sustainable suppliers, and local procurement.
- **Food Supply and Food Waste:** Partnering with local producers, promoting seasonal menus, and implementing food waste reduction practices across all departments.

Our Environmental Initiatives...

ち Energy Efficiency

- ✓ Use of low-energy or LED lighting throughout public areas.
- ✓ Outdoor lighting is managed through timers to minimize unnecessary use.
- ✓ Continuous monitoring and adjustment of air-conditioning in public spaces for optimal temperature control.
- ✓ Electricity in guest rooms is activated only via a magnetic key system.
- ✓ Air-conditioning and heating systems operate only when balcony doors are closed.
- ✓ Double-glazed balcony doors help maintain indoor temperature and reduce energy loss.
- ✓ Gradual replacement of outdated equipment with higher energy efficiency models.
- ✓ Preventive maintenance of all machinery according to the annual maintenance plan to avoid energy loss due to faults.
- ✓ Installation of air curtains in cold storage areas to minimize temperature exchange.
- ✓ Ongoing staff training and awareness programs to report malfunctioning or energywasting equipment.
- ✓ Ensure all electrical devices are turned off during non-operational hours.
- ✓ Bed linen is changed every third day to reduce water and energy use.
- ✓ Provide information to guests regarding energy-saving practices and towel use policies.

Water Conservation

- ✓ Water quality is regularly monitored to ensure compliance with national standards.
- ✓ Linen is changed every third day, unless otherwise requested by guests.
- ✓ Guests are encouraged to reuse towels and conserve water during their stay.
- ✓ Grey water is directed to the municipal sewage treatment system.
- ✓ Continuous maintenance and repair of leaks in pipes, taps, and equipment.
- ✓ Display informational signage in guest rooms to promote water-saving behavior.
- ✓ Staff training and awareness programs focused on responsible water management.

Maste Management

- ✓ Separate recycling bins are available throughout the property for glass, paper, cardboard, plastic, and metal, which are transferred to Green Dot recycling facilities.
- ✓ Ensure separate collection of used batteries, lamps, and electrical appliances.
- ✓ Promote paper reduction by encouraging staff to print only when necessary, using double-sided and black-and-white printing
- ✓ Digital communication tools (emails, e-documents) are preferred over printed materials.
- ✓ Reduce packaging waste through bulk purchasing whenever possible.

 Apply the "first in, first out" system for food storage to prevent spoilage and waste.

 Encourage guest participation in recycling and waste reduction initiatives.

🖍 Chemical Management

- ✓ Use of chemicals is strictly limited to cases where it is essential.
- ✓ Daily monitoring of swimming pools to ensure minimal chemical use while maintaining hygiene standards.
- ✓ Conduct regular training sessions for staff on safe handling and correct dosage of chemicals.
- ✓ Maintain Material Safety Data Sheets (MSDS) for all chemical substances on site.
- ✓ Ensure staff use appropriate Personal Protective Equipment (PPE) when handling hazardous materials.






Diagram 1: Customer Evaluation (Travel Agency 1)




Diagram 2: Customer Evaluation (Travel Agency 2)
